**Area World Service Committee Recommendations:**

Guidelines for Accepting Permanent Electronic Groups (PEGs) to Join Nebraska Area 33

I recommend to the Area that the Nebraska guidelines concerning voting procedures be updated as follows: Voting at Area Assemblies: To pass a recommendation shall require a 2/3's majority. All GR's present are eligible to vote. A YES vote agrees with recommendation. A NO vote disagrees with recommendation. An Abstention is neutral or not having an opinion. An abstention vote is not counted in the total GR's voting. Example: There are 30 GR's present. 19 vote Yes, 9 vote NO, And 2 Abstain. Total voting is 28. 2/3's equals 18.667. Recommendation passes.

I recommend to the Nebraska Area 33 guidelines concerning voting procedures be updated as follows: Voting at the Area World Service Committee: To pass a recommendation to send it to the Area Assembly requires a 2/3's majority. All members: Officers, Coordinators, DR's, Past Delegates, AIS Liaison present are eligible to vote. A YES vote agrees with the recommendation, A NO Disagrees with the recommendation. An ABSTENTION is neutral or not having an opinion. An abstention vote is not counted in the total Member's voting.
